End-User License Agreement

INTRODUCTION

These terms ("Terms") govern your access to and use of our website, <https://serversiding.xyz> (the "Website"), and the services we offer (the "Services"). By accessing or using the Website and Services, you agree to be bound by these Terms. If you do not agree to these Terms, you may not access or use the Website or Services.

SERVICES

We offer a service that lets you execute scripts and gain extra perks within supported Roblox games. We reserve the right to change, discontinue, or add to the Services at any time without notice. We also reserve the right to change the features, functionality, and content of the Services from time to time. We will make reasonable efforts to ensure that the information provided on the Website about the Services is accurate, but we do not guarantee that it will be complete or up to date.

LICENSING

(1) The client's acquisition and use of the Services shall serve as evidence of their agreement to the terms and conditions of this contract. In order to continue using the Services, the client agrees to abide by the provisions of this contract and to regularly review this document to ensure that they are aware of any changes to the usage policy. The client acknowledges that it is their responsibility to stay updated with the Terms of Service by visiting the Website and reading it prior to any usage of the Services.

(2) By acquiescing to the previous clause, the client acknowledges and agrees that their continued use of the Services constitutes their acceptance of and agreement to be bound by the latest version of the Terms of Service, which is perpetually made available to them on the Website, and that this agreement shall remain in full force and effect in perpetuity.

(3) The client represents and warrants that they have reached the age of majority in their jurisdiction, are at least 18 years of age, and are legally able to enter into a binding contract, in order to purchase access to the Services and use the Services. The client is expected to use the Services responsibly and with due care, as misuse of the product may result in unintended consequences. If we find that a user is under the age of 18, we will not hesitate to terminate the Services offered to that user.

(4) The client shall comply with any and all instructions provided by serversiding.xyz regarding the usage of the Services, and serversiding.xyz reserves the right to terminate the client's access to the Services if the client fails to comply with such instructions.

(5) The client shall not use the Services for any illegal or unauthorized purpose, and shall comply with all applicable local, state, national, and international laws and regulations.

(6) The client shall not engage in any activities that may interfere with or disrupt the proper functioning of the Services, including but not limited to hacking, distributing malware or viruses, or attempting to gain unauthorized access to the Services or other users' accounts.

(7) The client shall not reproduce, duplicate, copy, sell, resell, or exploit any portion of the Services without the express written permission of serversiding.xyz.

(8) The client shall not use the Services to engage in any activities that may be harmful to serversiding.xyz or its reputation, including but not limited to spreading false or misleading

information about the Services.

(9) The client shall not share or disclose their account information or login credentials to any third party, and shall be solely responsible for maintaining the confidentiality of their account information and for all activities that occur under their account.

(10) serversiding.xyz reserves the right to terminate the client's access to the Services at any time and for any reason, including but not limited to violation of these licensing terms.

(11) The serversiding.xyz staff reserve the right to revoke a client's access to the Services at any time, without prior notice or warning, provided that such action is justified by a breach of the Terms of Service or any other provision contained within this contract. The staff will make reasonable efforts to provide justification for any revocation decision, but such justification shall not be deemed an obligation or requirement for the exercise of their rights under this contract.

(12) In the event that a client's access is revoked by the staff, the staff member issuing the revocation shall provide the client with the reason for the revocation within 12 hours of the revocation being issued, unless the reason has already been automatically sent to the client through the email system. Any such reason for revocation shall be promptly documented internally.

(13) Any actions taken by a client in violation of the Terms of Service shall not be considered grounds for revocation unless such actions are also expressly prohibited by the provisions of this Agreement.

(14) In the event that a client believes that the revocation of their access is unfair, incorrect, biased, or was issued without the provision of a timely and appropriate reason, the client shall have the right to appeal the decision to the staff. The staff shall review the appeal and make a determination as to the validity of the client's concerns, and may, in their sole discretion, reverse the revocation if they determine that the client's concerns are justified.

(15) In the event that a client's access is partially revoked, they shall have the right to repurchase additional usage time.

(16) The client acknowledges that the Services provided by serversiding.xyz may change at any time, including but not limited to the addition or removal of the supported "games". The client understands that serversiding.xyz reserves the right to make changes to the Services as deemed necessary, and that such changes may result in the discontinuation of certain features or functionality.

(17) The client understands that serversiding.xyz shall not be held liable for any false advertising or misrepresentation of the Services. The client acknowledges that the descriptions and representations of the Services on the Website or in any marketing materials are for informational purposes only and may not reflect the current capabilities or features of the service provided.

(18) The client acknowledges that serversiding.xyz shall not be held liable for any damages caused by the revocation of their access to the Services as per the terms outlined in the licensing section. The client understands that such revocation may be necessary to protect the integrity and proper functioning of the Services, and that they will not hold serversiding.xyz responsible for any losses or damages resulting from such revocation.

(19) The client acknowledges that they are required to abide by the rules given to them upon purchase. Failure to abide by the rules given will lead to a blacklist.

(20) The client acknowledges that they have read and understood all the terms and conditions of this agreement and agree to be bound by them. They also understand that serversiding.xyz reserves the right to update, change, and modify the Terms of Service at any time, and that they are

responsible for checking for any updates and abiding by them.

(21) The client acknowledges that any key(s) redeemed on our Services that have been bought through third-party websites will be revoked if we deem that they have violated our Terms of Service.

(22) The client acknowledges that the availability of any specific supported game is not guaranteed and may end at any time due to changes made by serversiding.xyz or by the game's own developers, and that the removal, patching, or temporary unavailability of a game does not constitute a defect, a failure of the Services, or grounds for a refund, chargeback, or compensation.

OWNERSHIP

You shall not, under any circumstances, resell your account or any of the digital resources provided to you by serversiding.xyz, including, but not limited to, your account and the digital files associated with the Services. Any violation of this provision by you shall be considered a material breach of these Terms, and may result in the suspension or termination of your access to the Services, as well as the forfeiture of any credited time associated with your account.

PROHIBITIONS

(1) You shall not yourself, nor permit any third party to, reverse engineer, digitally analyze, or otherwise attempt to gain insight into the inner workings of the Services.

(2) You shall not use the Services, or any information or resources provided by serversiding.xyz, to develop or create any mechanism, tool, or software that is designed or intended to detect, or enable the detection of, the Services, their functionality, or any scripts written for use with the Services.

(3) You shall not engage in any activities that are intended to cause harm to other users of the Services, including, but not limited to, the distribution of malware, "trollware", cracked, or fraudulent scripts with the intent to do harm, as determined by serversiding.xyz staff in their sole discretion; the release, disclosure, or sharing of personal information about another user without their consent, with the intent to do harm; and the sharing and distribution of content that is illegal or prohibited, both publicly and privately. Any violation of this provision by you shall be considered a material breach of these Terms, and may result in the suspension or termination of your access to the Services, as well as the forfeiture of any credited time associated with your account.

GROUND FOR REVOCATION AND BLACKLIST

In addition to the conduct described above, the following will result in the suspension, termination, or permanent blacklist of your account, with no refund, as determined by serversiding.xyz staff in their sole discretion:

(1) Sharing your account, login credentials, or active session with any other person.

(2) Creating or using more than one account, or creating a new account to evade a ban, blacklist, or restriction.

(3) Using any third-party or external executor to run scripts, or loading any other service or code through our executor.

(4) Reverse engineering, decompiling, analyzing, or attempting to detect or fingerprint the Services, their functionality, or any scripts provided through them.

(5) Executing obfuscated, encrypted, or otherwise unreadable code, or any payload our scanners cannot statically analyze.

- (6) Running scripts or generating content that is sexual, graphic, hateful, or otherwise inappropriate.
- (7) Repeatedly crashing, wiping, or disrupting game servers, or otherwise driving down player counts at scale.
- (8) Leaking, sharing, screenshotting, naming, or otherwise revealing the identity of any supported or affected game to anyone outside the platform, on any channel.
- (9) Copying, exporting, reposting, reselling, or redistributing any script, account, key, or digital resource provided through the Services.
- (10) Mentioning, advertising, or otherwise exposing the Services inside any connected game, including telling other players that a game is affected or explaining how the Services work.
- (11) Attempting to jailbreak, override, or bypass the AI assistant's role or safety filters, or using the AI assistant for any purpose outside its intended scope.
- (12) Making, posting, or spreading any false, misleading, defamatory, or disparaging statement about serversiding.xyz, its staff, or the Services, whether publicly or privately.
- (13) Initiating a chargeback, payment dispute, or reversal against any purchase. We fight all chargebacks, keep records of delivery, and treat this as grounds for an immediate and permanent ban from all of our services.
- (14) Harassing, threatening, doxxing, impersonating, or abusing our staff or other users, including in our Discord server or any other public community space we operate.
- (15) Failing to follow any instruction given to you by our staff, including in the buyer's Discord you receive access to upon purchase.
- (16) Being under the age of 18, or providing false or misleading information about your age, identity, or eligibility.
- (17) Publicly disclosing, posting, hinting at, or speculating about the number of games we support, or the specific composition of our supported-game catalog, on any channel outside the platform. The size and contents of the catalog are confidential, and this is treated identically to revealing the identity of a supported game.
- (18) Breaking Discord's Terms of Service or Community Guidelines while holding a serversiding.xyz account. Our community and account integration operate on Discord, and a violation of Discord's rules is treated as an independent breach of these Terms that may result in a blacklist, notwithstanding that we are not affiliated with Discord.
- (19) Spamming, harassing, or coercing our staff or support channels, including to pressure us into adding specific games or features.
- (20) Engaging in toxic, hostile, dismissive, or disrespectful conduct toward serversiding.xyz, its staff, or its community in any of our community spaces. For the purposes of this clause, conduct includes any message, reply, reaction, emoji, image, or other signal that our staff, in their sole discretion, consider mocking, provoking, belittling, contemptuous, or otherwise corrosive to the community, whether directed at our staff, our posts or announcements, or other members.
- (21) Persistently undermining, disparaging, or degrading the tone of our community or the standing of our staff or the Services, whether through direct statements, passive or indirect remarks, or coordinated behavior, or otherwise conducting yourself in a manner our staff consider incompatible with our community standards.
- (22) Attempting to exploit gaps, ambiguities, or technicalities in these Terms in bad faith, or arguing that conduct our staff consider harmful is permitted merely because it is not expressly listed here.

These Terms are not exhaustive, and our staff's judgment governs.

(23) Spreading negativity, fear, or discouragement about the Services within our community, including claims that the Services are unreliable, in decline, at imminent risk, or not worth using, in a manner our staff consider corrosive to the community or our reputation.

(24) Instigating, escalating, or perpetuating drama, conflict, or hostility between members, or otherwise acting to divide, agitate, or destabilize our community.

(25) Airing disputes or grievances about us, our staff, or the Services publicly, indirectly, or through insinuation, rather than raising them through our support channels.

(26) Promoting, advertising, or favorably comparing a competing product within our community, or using our community to solicit or redirect our users elsewhere.

(27) Treating our staff or community with entitlement, contempt, or hostility, including demanding, ordering, or berating staff, or behaving as though our staff owe you service, priority, or an explanation.

(28) Deliberately baiting, provoking, or testing our staff or rules, including conduct framed as a joke, a test, or "just asking", where the intent or effect is to disrupt, agitate, or undermine.

(29) Sharing, screenshotting, or republishing our announcements, staff communications, or any members-only content outside our community.

(30) Continuing to press, relitigate, or repeatedly contact our staff about a matter after a decision has been communicated as final.

(31) Threatening negative reviews, public complaints, or reputational harm in order to obtain a refund, restored access, or any other concession.

(32) Knowingly filing false or bad-faith reports, fabricated bug reports, or otherwise deliberately wasting our staff's time.

(33) Threatening legal action, regulatory complaints, or the involvement of authorities as a means of intimidation or leverage, rather than in genuine good faith.

(34) Abusing our purchases, giveaways, or promotions, including a pattern of buying, using, and then reversing or refunding access.

(35) Appointing yourself as a moderator, taking enforcement into your own hands, or threatening, "punishing", or interfering with other users or with our moderation.

(36) Continuing conduct that would breach these Terms against our staff, our community, or the Services on other platforms, including social media, comment sections, or third-party servers.

(37) Attempting to extract access, credentials, keys, personal information, or other resources from our staff or members through deception, social engineering, or manipulation.

(38) Publishing a public review, rating, or testimonial about the Services that our staff, in their sole discretion, consider inaccurate, misleading, unfair, or unrepresentative of a genuine experience, including one that reflects expectations the Services never claimed to meet or that our staff otherwise consider not to reflect a fair assessment of the Services.

(39) Any other conduct that serversiding.xyz determines, in its sole discretion, to be harmful to the Services, to other users, or to our reputation.

USER CONTENT

You are responsible for any content or information you submit or post to the Services, including any text, photographs, videos, audio recordings, or other content (collectively, "User Content"). You represent and warrant that you own all rights to your User Content or, alternatively, that you have the right to grant us the license to use your User Content as described in these Terms.

DISCLAIMER OF WARRANTIES

The Website and Services are provided on an "as is" and "as available" basis. We do not make any representations or warranties of any kind, express or implied, as to the operation of the Website or Services, or the information, content, materials, or products included on the Website or Services.

LIMITATION OF LIABILITY

To the maximum extent permitted by applicable law, serversiding.xyz shall not be liable for any damages whatsoever, including but not limited to any direct, indirect, special, incidental, or consequential damages, arising out of or in connection with the use or inability to use the Website or Services. This includes, but is not limited to, damages for loss of profits, goodwill, use, data, or other intangible losses, even if serversiding.xyz has been advised of the possibility of such damages.

INDEMNIFICATION

GOVERNING LAW

DISPUTE RESOLUTION

If a dispute arises out of or relating to these Terms, the Website, or the Services, you agree to first contact us at legal@serversiding.xyz so we can attempt to resolve it informally. Any dispute that cannot be resolved this way shall be subject to the exclusive jurisdiction of the competent courts of the country in which serversiding.xyz is established. Nothing in this section affects any mandatory statutory rights you have as a consumer under European Union law.

ENTIRE AGREEMENT

These Terms constitute the entire agreement between you and serversiding.xyz regarding the use of the Website and Services, and supersede all prior or contemporaneous communications and proposals, whether oral or written, between you and serversiding.xyz.
